## FOR YOUR INFORMATION

It has come to the attention of the Board of Directors that some Members are not signing it at the front office and / or on the 2P Range or 200 yard range. This is a serious breach of our rules and will result in a minimum penalty of a 30 day suspension of range use and a \$200.00 fine. Only Members of record may shoot on the 2P range. Violation of this policy will result in a six month suspension of range use and a \$500.00 fine. Only Members and guests that have been approved may use the 200 yard range. MAKE SURE TO SIGN YOURSELF AND YOUR GUEST(S) IN AS SOON AS YOU ARRIVE AT THE RANGE. No exceptions.

**CONCEALED CARRY:** Members and guests holding a valid CA legal CCW permit may carry concealed on Member Days (only) provided the firearm is properly concealed while on the range property. No firing from concealed unless on the 2P Range.

## IMPORTANT MEMBER INFORMATION UPDATE

The Member Handbook – House Rules have been modified with the follow additions:

### **2P Range:**

For Environmental reasons, all Members are limited to 400 rounds per week on steel targets.

### **Tin Can Ranges:**

No use of alcohol containers on the Tin Can range. No empty alcohol containers to be brought on to range property. No empty alcohol containers to be disposed of on range property.
