## Youth Group Range Use Agreement



Thank you for your interest in scheduling a youth group shooting event at the *Los Altos Rod and Gun Club Range!*

**Free admission:** The Club provides non-profit youth groups free admission for youths and their adult supervisors. The purpose of this program is to give youth an opportunity to learn basic firearm safety and experience the sport of target shooting in a safe and comfortable environment.

**Maximum group size:** To maintain safety with appropriate levels of staff, we can accommodate **no more than 20 people** in any such group, including all youths, adult supervisors, and instructors. To maintain proper safety, each group should include at least one supervising adult for every five youths. Groups exceeding the size limit—even with additional paid admissions—may be ejected.

**Reserving a date:** At least 21 days before your planned visit, the group leader must request via email the date and exact number of adults and youths to attend. Because only one group of 20 will be scheduled on any public range date, the Range will let you know if that day is available, but will not reserve the date until the number of attendees has been confirmed. The group leader must sign and submit a copy of this agreement form no later than 14 days prior to the event date.

Groups may also reserve the barbecue grill and picnic facilities.

**Waivers an permission forms:** Each adult must sign a waiver and each youth must have a permission form signed by their parent or legal guardian.

**Rules:** Before entering the shooting ranges, each person must read and agree to follow the Range's rules, and have their own eye and ear protection and wear them during shooting sessions. As stated in the rules:

- The Range does not provide, rent, or sell guns.
- Supervising adults must assure that youths will not roam without adult escorts, including going to or from restrooms.
- Supervising adults must be active in their supervision, so supervising adults may not shoot while their assigned youths shoot. Supervising adults must be within arm's reach of the youths while the youths shoot.

**Scouting groups:** Members must be in uniform, including supervising adults. Each scouting group is responsible for knowing and understanding their scouting organization's requirements for instructors (such as NRA certifications, etc.).

With the Range nearly 3000 feet in the mountains, its weather may change quickly. The group leader is responsible for assuring all group members have clothing appropriate for conditions (coats, gloves, hats, sunscreen, insect repellent, rain gear, closed toed shoes, etc), as well as water, snacks, and any other comfort items.

For your convenience, the Range sells eye and ear protection, targets, ammunition, clothing, beverages, snacks, frozen food, and ice cream.
